

**Committee to Study Dissolution  
Regional School District No. 11  
Minutes of the Meeting of January 3, 2018**

**I. Call to Order**

The meeting was called to order at 6:01 p.m.

**III. Review and Approval of Draft Paragraph Explaining Vote Per C.G.S. Sec. 10-43**

Mr. Venhorst explained that Connecticut General Statutes Sec. 10-43 requires that, if the committee finds dissolution to be inadvisable, the Committee’s report include “findings and an explanation of the reasons for its conclusions.” The Committee discussed this requirement and settled on the following language for insertion in the Committee’s final report:

The Committee believes at this time that there is insufficient evidence of cost savings presented to justify dissolution of the district. While declining student enrollment is a concern, the evidence gathered by the Committee reveals that Parish Hill offers a positive educational experience for students and families. The Committee also believes that schooling alternatives available in the event of dissolution would be accompanied by significant costs, and that dissolution would be highly disruptive to students.

Ms. D’Appollonio moved, and Mr. Hooper seconded, that the above language be used and added to the report:

Ms. Nelson indicated that she would submit the final report/appendices to the State Board of Education and the Towns mid-week during the week of January 8, 2018.

Ms. Nelson opened up to meeting for public participation. One member of the public expressed the view that dissenting members of the Committee should state in writing why they dissented, and further stated that issue of dissolution should go to referendum regardless of the Committee's vote. Another member of the public expressed his view that dissolution would have resulted in significant cost savings and that the State should pay more money to the towns within the region.
