BACKGROUND

- May 2023 Town Meeting non-binding vote in favor of project (25 In favor – 3 Opposed)
- \$752,000 received from Community Connectivity Grant in July 2024
- Spring 2025 met with Library Board, Historic District Commission, residents, and Town Staff to receive input
- May 2025 Town Meeting Updates provided to residents.

- State Historic Preservation Office review and approval
- State Natural Diversity Database review and approval
- Planning & Zoning approval contingent on the Town hosting an information meeting

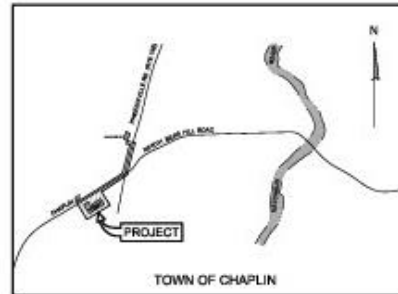

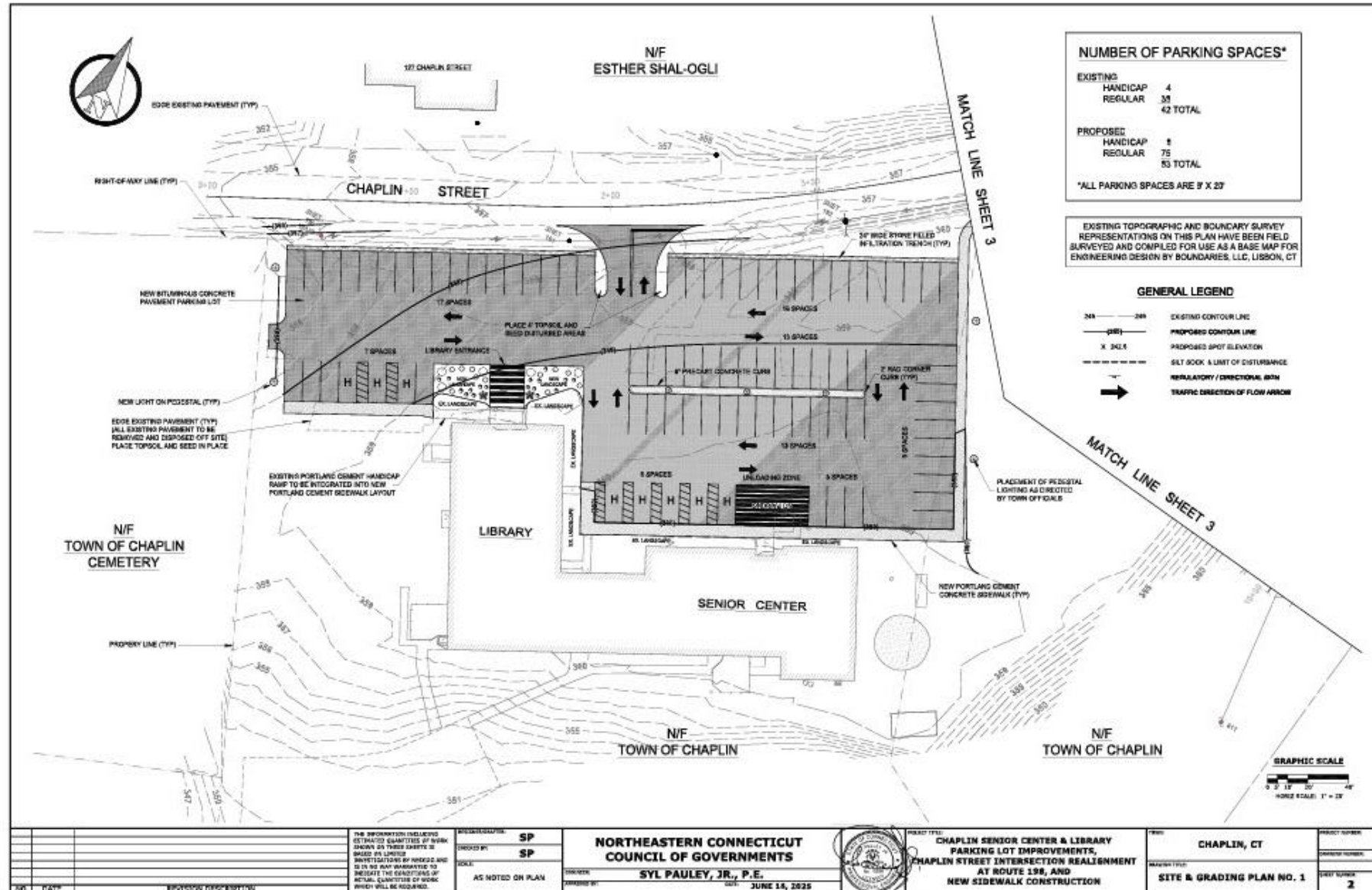

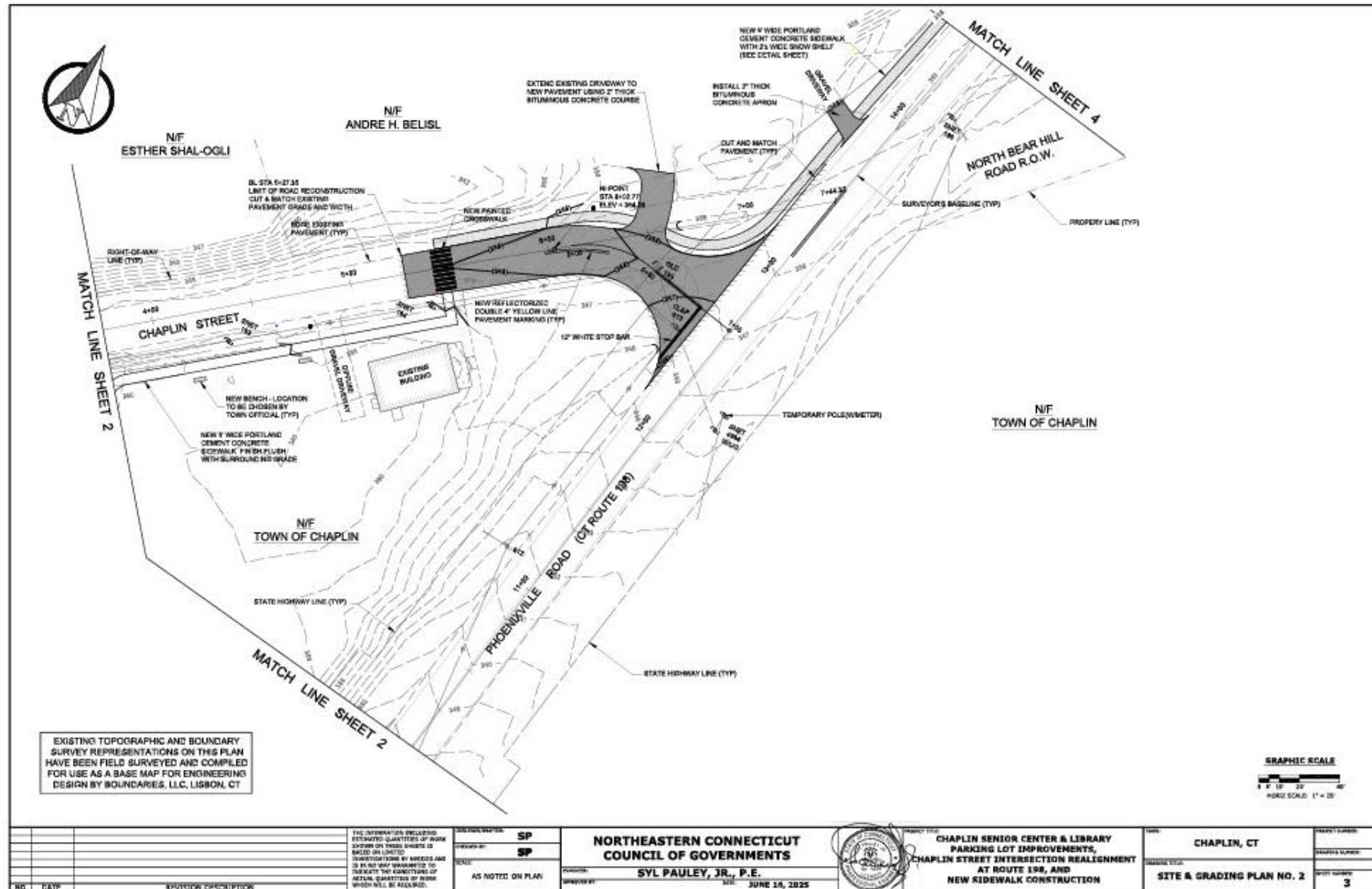

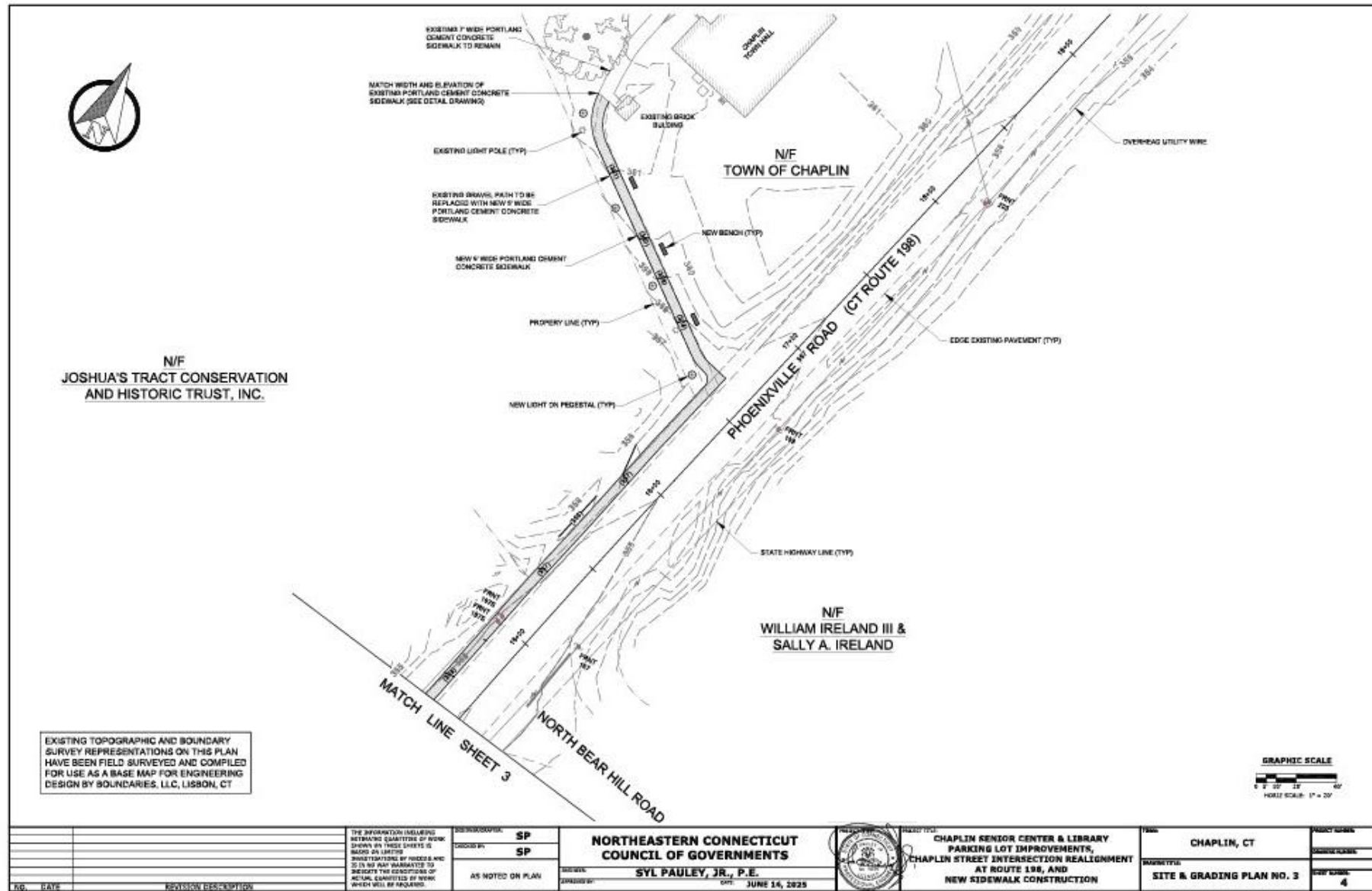
