 - a. Review audit Q&A for BOF members after presentation:

The FY 2022-23 Chaplin Audit was presented with a clean unmodified opinion (no internal control issues or compliance issues). The Unassigned Fund Balance of 15% is a respectable number. Revenues were better than expected with \$47,000 from new OPM Tiered Pilot Grant. Total Expenditures were \$192,000 underbudget.

- Dick Weingart asked if any State Grants fall into the spend it or return it category (smaller educational grants early child care but generally not); expressed concerns about the amount of uninsured and uncollateralized (STIF investments secure more liquid, banks offering CDs pooled with other entities that are covered 100% by FDIC not as liquid); and asked if the Pilot Tiered program will continue (might continue due to being included in compliant supplement).
- Victor Boomer asked if there are any major flaws with how things are done or any suggestions (very happy with how things handled with no recommended changes).
