4. Executive Session: Discussion of Chaplin Education Association Professional Agreement Successor Contract

(1) to discuss strategy and a potential settlement with the Chaplin Education Association regarding a successor collective bargaining agreement to that which expires on June 30th, 2026; and to review documents related to the same which are exempt from public disclosure pursuant to Connecticut General Statutes sections 1-200(6)(E) and 1-210(b)(9); and

(2) To review and discuss documents from the Board's legal counsel that are exempt from public disclosure

c. William Hooper made a motion to approve and accept the agreement for a successor collective bargaining agreement with the Chaplin Education Association, with a three year duration; commencing on July 1st 2026 and ending on June 30th, 2029. 2nd by Gene Boomer. (1) The contract must be signed by the appropriate designated officers and/or members of the Chaplin Education Association; and

(2) The Board hereby delegates to the Chair the authority to sign the final contract document on behalf of the Board counsel to ensure the final contract documents sets forth the accurate agreement of the parties; and

(3) The Board hereby delegates to the Chair the authority to coordinate with Board counsel to file the fully-executed Contract with the Town Clerk's Office and to otherwise complete the process required by the Teacher's Negotiations Act.
