A. <u>Basketball</u>: Dave reported that there are 46 participants this year which is a decrease from last year. C. <u>DiscGolf</u> : Brian addressed Commission reporting on tournament held at Garrison Field. There were 21 participants and he felt that it was very successful. He would like to hold 3 additional tournaments, one in March, one in Summer and one in Fall. He also reported that he would like to continue the Glo League meeting every two weeks. Rec. Commission thanked Brian for his time to hold these events. Dave asked about the signs for each hole that have not yet been set up. Brian will make sure they are in before winter.

D. <u>Cornhole</u> : Discussion about winter league took place. Dave reported that the Firehouse hall has been secured for games. Games will be held on Sundays and Wednesdays beginning at 6 pm. There will be two different leagues, 6 games per night with random match up. with two teams playing per night. Start night will be Dec. 29 and Jan. 2 lasting eleven weeks. One week for make up games.
