New Business: Mr. Bob Mott, Marcy Road. Construction of single family residence in upland review area. Members were presented with site plan and photos. Zoning Official Damien did prep work, knows the area and also a soil scientist. Mr. Mott and Wetlands Agent had already reviewed map. Zoning official gave wetlands delineation. Mr. Mott gave details for proposed fill cut, fill volumes total is 686 cubic yards. 250 cubic yards for total cut and net cut fill is 436 cubic yards to balance site. Mr. Mott discussed in detail base flood elevation. Soil was tested with 5 test pits and there are not any flood plain soils. Joe Theroux asked if there was a separate delineation report from Jeff Polhemus. Mr. Mott pointed out that the information was on the map already in the notes section. He did not receive a separate report/letter. It was suggested that a site walk be done by the members of the Commission. Commission in agreement. A group site walk could not be organized, due to everyone's schedules. Members will go at their own convenience. Ginny Walton asked Joe Theroux if he would walk the site with her. He agreed and will set a date and time. Mr. Mott will stake out accessory building & house site. Further discussion and questions from the members continued. The proposed house site was above water in the 2010 floods. House will not have a basement, just crawl space. The Commission can act on the application/plan the next meeting. Paul Deveny (?) made a motion to accept the plan. Ginny Walton seconded it. All in favor motion carried.

Correspondence: Chairman Matthies let the Commission know that the budget was approved.

Administrative Report: North Bear Hill Bridge (E&S measures) and North Bear Hill will be needing road improvements to redesign the culvert. Agent Theroux was letting the Commission know that this will be coming before the Commission in the near future.
