### Minutes

## **Special Meeting**

## Tuesday, September 30, 2025

These unapproved Historic District Commission meeting minutes are forwarded to the Chaplin Town Clerk in a draft format. These minutes are unofficial until they have been read and approved by a majority vote of the Commission. Should edits be necessary, they will be made at the next regularly scheduled meeting, voted upon and noted in the meeting minutes.

- I. Roll Call and Seating of Alternates. Chairman W. Church called the meeting to order at 7:00 P.M. Present were regular members P. Peifer, L. Ricklin, D. Field, W. Rose. Also present was Alternate member B. Kelleher. Alternate member M. Connor was absent.
- **II. Approval of September 9, 2025 Minutes.** Mr. Rose moved to approve the minutes, Mrs. Ricklin seconded, motion passed unanimously. At this time Chairman Church recused himself from discussion of item IV. Fence at 127 Chaplin St. because he is the next door neighbor. He turned the meeting over to Vicechairman Ricklin.

#### III. Audience for Citizens. None

- IV. Fence at 127 Chaplin St. Mrs. Ricklin informed the members that Ms. Shali-Ogli, owner of 127 Chaplin St. has not responded to Mr. Church's request to submit an application for a Certificate of Appropriateness for the chain link fence she installed along the side and rear of her property. The fence is visible from the street. Mr. Church gave her a copy of the HDC regulations and she knows there is a process to follow in the District. Mr. Peifer said the HDC should send a certified letter requesting the application for C of A. Mr. Peifer reviewed the State Statute 7-147 A-K regarding historic districts but there was no mention of penalties. Mr. Rose brought up a Town ordinance about non-compliance penalties and thought Town Attorney O'Brien should be consulted to see if that applies in this case. The HDC was informed about posters Ms. Shali-Ogli put on her road side fence that told everyone she has cancer and pictured an email communication between Mrs. P. Church and Ms. Shali-Ogli that included a suggestion on how to mask the chain link fence and an offer of transportation to cancer treatments. Mrs. Field thought the screening and door on the porch was a bigger issue since it changed the appearance of the house itself. Mrs. Ricklin agreed that the District needs an acceptance to abide to the regulations and the HDC must pursue enforcement or lose the character and integrity of the District. Mr. Rose wants to make sure the penalty ordinance applies. He made a motion to authorize Mrs. Ricklin to contact Town Attorney O'Brien to get a definitive answer on the ordinance and to compose a letter requesting Ms. Shali-Ogli submit an application for a Certificate of Appropriateness by a certain date to the HDC to be sent certified mail to Ms. Shali-Ogli. Mrs. Field seconded the motion, W. Rose, D. Field, L. Ricklin and P. Peifer voted to approve, W. Church abstained.
- **V. Correspondence.** Peggy Church presented printed copies of a photo of the poster that was attached to the fence at 127 Chaplin St. and the email conversation between Ms. Shali-Ogli and herself. Mrs. Field thought Ms. Shali-Ogli was rude and insulting to Mrs. Church in response to Mrs. Church's offers of help.
- VI. Adjournment. Mrs. Field made a motion to adjourn, Mr. Rose seconded. Meeting adjourned at 7:38 P.M.
