The new building would eliminate three existing, smaller outbuildings on the property. Chairman Matthies asked if he would consider putting up a smaller building to take it out of the wetlands. Mr. Coogan stated that there is a 36 x 50 steel building that would be an option. He stated that the existing sheds would be torn down and put in dumpster. Agent Joe Theroux stated that he went on site to do an inspection of the wetlands. It is a typical palustrine forested wetland, red maple swamp. The area adjacent to the garage is rocky, no soil and that the wetlands are west of the property. Mr. Coogan discussed what trees he will be taking down and Agent Theroux concurred mostly saplings with a couple of larger trees. Also discussed was soil removal and storage and how he will get a truck in to pour the cement.

The commission agreed to do a site walk on 6/9/2020 at 5:30pm. The Commission cannot act on this application until after the site walk and next months meeting. Applicant to work with Agent Theroux on more details of the plan, i.e. silt fence, redraw building as 36 x 50, etc.
