I. PURPOSE AND GENERAL INFORMATION

It is the intent of this Request for Proposal to solicit bids for professional asphalt services for the Town of Chaplin, through its Public Works Department. Town of Chaplin is inviting proposals from State of Connecticut licensed Contractors to provide construction and reconstruction of the designated roadways within Town of Chaplin. The work is scheduled to be performed from July 1, 2019 – October 31, 2019. The paving projects must be completed by the October 31, 2019 deadline. The shimming projects must be completed within one month from written request from the town and may be done per request up to but no later than June 30, 2020.

II. SCOPE OF SERVICES

A. Canada Lane:

Two (2) Keyways milled at the intersections of England Road and South Bear Hill Road as marked by Chaplin Public Works.

One leveling layer of Class 2 asphalt installed over the entire existing roadway to a compacted thickness of 1inch.

One top coat lift of Class 1 asphalt installed over the entire existing roadway to a compacted thickness of 1.5 inches.

Any and all driveways shall be matched to the new height of asphalt with or without existing aprons.

Tonnage receipts shall be turned in to the Department of Public Works within 48 hours of completion of project and SHALL prove a minimum tonnage usage for Canada Lane of 800 (eight hundred) tons of asphalt.

B. Old Hampton Road:

Western Section of Old Hampton Road starting at Cross Road:

Saw cut the intersection of Cross Road and the paving "end line" as marked by Chaplin Public Works.

Saw cut driveway aprons as/where needed and approved by Chaplin Public Works.

Rip out approximately 250 feet of length and entire width of existing asphalt between Cross Road and "end line" as marked.

Remove old asphalt from site. This material may be either disposed in designated area on Old Hampton Road or removed entirely from town property. (Bidder to specify intensions)

Base material graded and compacted in preparation for new roadway.

One base course of Class 1 asphalt installed to a minimum compacted thickness of 1.5 inches.

One top course of Class 1 asphalt installed to a minimum compacted thickness of 1.5 inches.

The base course shall be installed to a width of 18 feet. The Northern edge of which will contact the driveways.

The top course shall be installed to a width of 18 feet. The Northern edge of which will contact the driveways.

Eastern Section of Old Hampton Road starting at "end line":

Saw cut the apron at the "end line" as marked by Chaplin Public Works.

Saw cut the driveway apron as/where needed and approved by Chaplin Public Works.

Rip out the entire width of existing roadway and lengthwise between saw cuts. Remove old asphalt from site. This material may be either disposed in designated area on Old Hampton Road or removed entirely from town property. (Bidder to specify intensions)

Base material graded and compacted in preparation for new roadway.

One base course of Class 1 asphalt installed to a minimum compacted thickness of 1.5 inches.

One top course of Class 1 asphalt installed to a minimum compacted thickness of 1.5 inches.

The base course shall be installed to a width of 18 feet. The Northern edge of which will contact the driveway.

The top course shall be installed to a width of 18 feet. The Northern edge of which will contact the driveways.

Tonnage receipts shall be turned in to the Department of Public Works within 48 hours of completion of project and SHALL prove a minimum tonnage usage for Old Hampton Road of 210 (two hundred ten) tons of asphalt.

C. Shimming daily equipment and labor:

Class 2 asphalt will be provided by the contractor to be used for shimming to be performed on various roads to repair defects as well as improve drainage.

The contractor shall provide the following minimum equipment and labor to perform road shimming as requested.

- One paving box with operator
- One compactor with operator (minimum 3 tons)
- Two Tri-axel dump trucks with drivers.
- One laborer

The contractor shall provide a daily rate for equipment and labor (based on an 8-hour work day including travel to and from the job location anywhere in the Town of Chaplin and the contractors listed place of business.

D. Shimming overtime equipment and labor:

The contractor shall also provide an hourly rate for overtime per hour beyond 8-hour day.

The Town of Chaplin reserves the right to approve or deny the use of overtime on a case by case basis contingent on verbal agreement between the contractor and Chaplin Public Works on that day prior to completion of the work day.

E. Provide a pricing for Class 2 asphalt for shimming.

Note: Asphalt tonnage receipts shall be turned in to the Department of Public Works within 48 hours of completion of project and SHALL prove a minimum tonnage usage for Old Hampton Road of 210 (two hundred ten) tons of asphalt.

III. RESERVES THE RIGHT TO REJECT

The Town of Chaplin reserves the right to select the service provider which best meets the Town's goals and objectives, needs, budget constraints, and quality levels, as well as its service level expectations. The Town reserves the right, in its sole discretion, to reject any/or all proposals, to waive any irregularities and technical defects contained therein, to award the contract in its entirety, in part or not at all and/or to determine which proposal is the lowest and/or best to enter into a Contract, as it may deem to be in the best interest of the Town of Chaplin.

IV. PREPARATION OF THE PROPOSAL

Proposals should provide a straight forward, concise description of the proponent's capabilities to satisfy the requirements of the RFP. Emphasis should be on completeness, clarity of content, and conveyance of the information required by the Town of Chaplin. One (1) entire original proposal must be submitted to the Chaplin First selectman's office by Thursday, May 30th, 2019 at 2:00 pm. The original must be marked as an original. At a minimum, the proposal should contain the following information:

- Business Organization State the full name, address, phone number, fax number and email address of your business and whether you operate as an individual, partnership, or corporation.
- List of business's experiences with federal, state or municipal programs pertaining to asphalt paving projects.
- Proof of appropriate state certifications Provide proof that you are licensed to operate in Connecticut.
- Qualifications Include a brief narrative description of the proposed services that will
 be delivered and the equipment available to perform the services. Please indicate
 completed projects of similar nature. Also indicate a contact person for each reference
 cited.

V. INSURANCE REQUIREMENTS - CERTIFICATE OF INSURANCE

The contractor shall furnish certificates of insurance in the following accounts:

- Comprehensive General Liability including premises/operations, contractual independent contractors, broad form property damage and personal injury. Limits of liability shall be combined bodily injury and property damage:
- Auto liability, including owned, non-owned and hired limits of liability shall be combined bodily injury and property damage: \$1,000,000. Each occurrence: \$1,000,000 Aggregate.

- Excess Liability Umbrella Form: \$1,000,000
- Workers' Compensation Insurance Limit of liability shall be the statutory limits. State whether the sole proprietor and/or partners have elected to be included.
- The contractor shall have a certificate issued showing the Town of Chaplin as an additional named insured for the duration of the contract.
- Certificates shall be filed with the town's agent before work is started and contain a thirty (30) day written notice of cancellation clause.
- All personnel on site shall follow ANSI and OSHA standards for personal protective equipment.
- Contractor shall be responsible for damages incurred to town or personal property within the work zone.

VI. AGREEMENT/EXCEPTIONS

Submission of a proposal indicates the Contractor agrees to the terms, conditions and other provisions contained in the RFP, unless the Contractor clearly and specifically presents in its proposal any exceptions to the terms, conditions, and other provisions contained in the RFP. Exceptions presented in a proposal are not to be considered incorporated into the contract between The Town of Chaplin and the selected Contractor unless and until The Town of Chaplin agrees to accept such exceptions. The selected Contractor must acknowledge and agree that the contract resulting from this RFP includes the terms, conditions, and other provisions contained in the RFP, the proposal selected (including any exceptions accepted by The Town of Chaplin) which is acceptable to The town of Chaplin and is not in conflict or contravention of the RFP, and any other documents mutually agreed upon by The Town of Chaplin and selected Contractor. No oral statements or any person shall modify or otherwise change or affect the terms, conditions, or specifications stated in the RFP or the resulting contract. A formal contract will be awarded after the selection of a contractor for the services identified in the scope of services by The Town of Chaplin. The contractor shall not assign the contract or any part thereof to any other person unless such assignment is first approved in writing by The Town of Chaplin, it being understood that the contract shall not be assignable unless the proposed assignee is acceptable to the municipality. The request for assignment must include evidence that the proposed assignee qualifies under all requirements of the contract and must be addressed as defined in the contract for services.

VII. PROPOSAL SUBMITTAL

One entire original proposal must be submitted to the Chaplin First Selectman's office as follows: Town of Chaplin 495 Phoenixville rd. Chaplin CT 06235. All proposals must be received prior to Thursday, May 30th, 2019 at 2:00 pm. Proposals may be mailed or dropped off at the Chaplin Town Hall. Proposals must be received in the First Selectman's Office by 2:00 pm for it to be considered in the RFP review process.

VIII. EVALUATION OF PROPOSALS

Only proposals meeting minimum qualifications will be evaluated. Certification by the State of Connecticut is required. Personnel must be State of Connecticut licensed. The Town of Chaplin will evaluate proposals based on, but not limited to, the following criteria:

- Experience in asphalt road paving and rehabilitation
- Capability of contractor and/or personnel
- References
- Price the Town of Chaplin reserves the right to accept or reject any or all proposals, in part or in total, and to waive any irregularity in any proposal if it is deemed to be in the best interests of The Town of Chaplin. The Town of Chaplin reserves the right to reject the proposal of any contractor who has previously failed to perform properly, or to complete on time, contracts of a similar nature, who is not in a position to perform the contract, or who has habitually and without just cause neglected the payment of bills or otherwise disregarded his/her obligations to subcontractors, suppliers, or employees. The Town of Chaplin reserves the right to make an award based solely on the proposals submitted or to negotiate further with one or more vendors. The contractor selected for the award will be chosen on the basis of greatest benefit to The Town of Chaplin, not necessarily on the basis of lowest price. All costs incurred in the preparation and presentation of the proposal shall be wholly absorbed by the contractor. All supporting documentation and manuals submitted with this proposal will become the property of The Town of Chaplin unless otherwise requested by the contractor at the time of submission.
