MEETING MINUTES
November 15, 2016
7:00pm**

Parish Hill Middle/Senior High School Library

Chairperson Stephen Dunn called the meeting to order at 7:07pm. Present were board members Kate Donnelly, Bud Smallwood, Sally Ireland, Jennifer Nelson, Kathleen O'Callaghan, Stephanie Harrington and Rose Bisson. Administrators present were Superintendent Ken Henrici and Principal Brian Tedeschi.

The Board recited the Pledge of Allegiance.

1. **Communications with the Audience** – Kim Martin spoke to the board concerning the employment of armed guards at the school and presented some comments that local town people had on the idea.

Jennifer Nelson moved to add an executive session to the agenda for the purpose of discussion on the security presentation. Bud Smallwood seconded and the motion passed with the following vote:

Rose Bisson moved to move the Executive Session for Discussion of 45% Rule as it pertains to the employment of the Superintendent to two on the agenda. Kathleen O'Callaghan seconded and it passed unanimously.

2. **Executive Session – Discussion of 45% Rule as it Pertains to the Employment of the Superintendent** – Rose Bisson moved to enter executive session (7:24pm) for the discussion of 45% Rule as it pertains to the employment of the Superintendent with Superintendent Ken Henrici, First Selectman Daniel Syme and Attorney Don Houston invited to attend. Kathleen O'Callaghan seconded and the motion passed unanimously.

3. **Written Communications to the Board** – Stephen Dunn shared a thank you letter he received from Superintendent Ken Henrici.
4. **Approval of October 18, 2016 Minutes** – Rose Bisson moved to approve October 18, 2016 minutes. Kate Donnelly seconded and the motion passed unanimously.
5. **Approval of Financial Statement** – Sally Ireland moved to approve the Financial Statement ending September 30, 2016. Rose Bisson seconded and the motion passed unanimously. Sally Ireland moved to approve the Financial Statement ending October 30, 2016. Rose Bisson seconded and the motion passed unanimously.
6. **Administrative Reports/ Administrative Request for Board Action**
 - A. **Principal** – Principal Brian Tedeschi reported to the board on Helping hands food drive, Junior Planning Meeting, a recent Distracted Driving Assembly the school held, Parent/Teacher Conferences, how the school's teams had done in their respective conferences and some upcoming events were the school choir would be performing. He also informed the board that the NEASC visited went well but that the full report would not be back to the school for six months.

 - i. **CAPSS Superintendent's Award Ceremony – RHAM HS – November 2** – Superintendent Ken Henrici informed the board of the four students that would be honored at this ceremony.
 - ii. **SBAC and CAPT/CMT Student Awards – December Meeting** – Superintendent Ken Henrici informed the board that many students would be honored at the meeting.
 - iii. **Veterans Luncheon and Ceremony** – Superintendent Ken Henrici reported to the board on the success of the luncheon and highlighting some of the Veterans that attended.
 - iv. **Technology Support Person Vacancy** – Superintendent Ken Henrici informed the board that Tom Mason's last day will be December 2, 2016 and that they have already placed ads for the vacant position in the Norwich Bulletin and on CT REAP website.

- v. **NEASC Visit** – Superintendent Ken Henrici echoed the statements the Principal Brian Tedeschi made on the visit.
- vi. **New Athletic Conference for Parish Hill – 2017/2018** – Superintendent Ken Henrici informed the board that next year the school sports team will no longer be in the Constitution State Conference but instead will compete in the Capital Regional Athletic League.
- vii. **Proposal for Grade 6 Students “Playing Up” to Middle School Teams** – Superintendent Ken Henrici informed the board that he had been approached by parents’ of Elementary School students who were interested in their child playing on the middle school team. After speaking to the Athletic director, the Superintendents of the Elementary Schools and Coaches it was determined that grade 6 students could “Play Up” on a Middle School team as long as they don’t miss any school instruction and absolutely no money is spent on transportation.
- viii. **Allied Health/EMT Update** – Superintendent Ken Henrici informed the board that a meeting was held with Allied Health about an exploratory course for 7th and 8th graders. They have also been looking at a similar course that E.O Smith has to help get this up and running.

Superintendent Henrici and Board Member Jennifer Nelson both fielded the question and responded that it did also apply to non-certified staff. First Select Daniel Syme asked about possible lighting out in front of the building. Superintendent Ken Henrici said that he would look into this.
