1. Call to order: 6:11 pm
2. First audience for citizens: none
3. Secretary's Report: **Motion** made to accept the minutes of Special Meeting held on May 7 as presented made by Dave and second by Matt. All in favor. Motion carried.

6. Summer Music: Plans to hold the July Concert in the Park on July 11 have not been cancelled yet. Commission will investigate guidelines by the State for Outdoor events to see if this event can continue. Dave will communicate with Jeff Burnham (Tuesday Saints) to see if he would like to go ahead with the concert.
7. Town Tag Sale: Discussion was held about holding a Town-wide Tag Sale. A date was set to hold it if possible on Sept 19, 2020 from 8am – 2 pm. Participants can choose to have it at their own home or at Garrison Park. The

Commission would advertise this event on their website which would provide advertisement for all involved. The Commission would charge \$5 for anyone wanting to participate at their home. This would cover the cost of advertising the event. A fee of \$25. would be applied to anyone wanting to have a space at Garrison Park. This would be for a 10 x 10 ft space with a table provided.

9. Purchase of Box Grader: Discussion was held on the benefits of purchasing a box grader to maintain the walking path at Garrison Park. Two quotes were reviewed. **Motion** was made by Matt to purchase the 5 foot box blade for \$930.00. Second by Russ. All in favor. Motion carried.
